- 4 The Tender Paper cost is amounting to Rs 10,000.00 (Rupees ten thousand) only.
- 5 Bids shall be received only "on line" on or before 17.00 hours of dt. 17.02.2024. The bidder desirous to participate in bidding must possess compatible Digital Signature Certificate (DSC) of Class-II or Class- III and should follow the changes / modifications / addendum to DTCN if any.
- 6 A pre bid meeting shall be held at 11.00 hours of dt.07.02.2024 in the office of the Executive Engineer, RWS&S Division, Rairangpur to clarify the issues and to answer question on any matter that may be raised at that stage as stated in Clause 9.2 of the bidding document i.e. 'Instruction to Bidders'.

- 7 Bids received on-line within due date and time shall be opened at **11.00 hours of 19.02.2024 in the office of the Executive Engineer, RWS&S Division, Rairangpur** in the presence of the bidders or their authorised representatives who wish to attend. Bidders can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. The original documents within a specified period after opening of the tender.
- 8 Bids must be accompanied with electronic receipt through payment gateway of designated banks such as **SBI/ ICICI/HDFC bank for bid security and cost of bid documents** as specified for the work in the table along with bid documents during online submission vide Office Memorandum No. 17254 dated 05.12.2017 of Works Department Govt. of Odisha. **The cost of bid documents & bid security shall be paid through online through RTGS/NEFT from designated bank such as SBI/ ICICI/HDFC bank located in the state in favour of Executive Engineer, RWS&S Division, Rairangpur.** Bid security @ 1% of the value of work (only amount to be inserted in para-1 above of NCB) Note : Bid security will be fixed sum rounded off the nearest ten thousand Rupees. - 9 Bids must be accompanied by amount of EMD in shape of NSC/KVP/TDR/Bank Pass Book/ Postal Pass Book specified for the work in the above table duly pledged in favour of the Executive Engineer, RWS&S Division, Rairangpur. Bid security @ 1% of the value of work (2% in case of outside the State bidder) Note : Bid security will be fixed sum rounded off the nearest ten thousand Rupees. Bidder must upload the copy in tender portal upto dt. 30.12.2023 upto 05.00 P.M. and submit the original copy of Bid Security at RWS&S Division, Rairangpur on or before dt 06.01.2024 failing for the work with the tender documents otherwise his/ her bid will be rejected without further intimation.
- 10 However Additional performance security (APS) need to be deposited only by the successful bidder in shape of Terms Deposit (TD) / Demand Draft (DD) in favour of Executive Engineer, RWS&S Division, Rairangpur and have to furnish the exact amount of differential cost within 7 (seven) days, otherwise the bid shall be cancelled and SD shall be forfeited and proceeding for blacklisting shall be initiated against bidder.
- 11 The authority reserves the right to reject any or all bids or cancel the bidding process at any point of time without assigning shall be initiated against bidder.
