The Additional Chief Engineer, Northern Minor Irrigation Circle, Sambalpur on behalf of Governor of Odisha invites **on-line percentage rate** tenders in **double cover system** through e-procurement for execution of the work noted below. The bid should be submitted by eligible class of contractors as mentioned below registered with State Government & contractors of equivalent grade / class registered with Central Government / MES / Railway to be eventually drawn in **P-1** form through **On-line** in the Govt. website www.tendersodisha.gov.in. The bidders should have necessary portal enrollment (with own digital signature certificate). The registered bidders outside Odisha state can also participate in this on-line tender process after necessary portal enrollment but shall have to subsequently undergo registration with appropriate authority of the state government within a month of acceptance of bid. The bidders registered outside the state are required to submit an undertaking in the form of an affidavit, that they are not registered under the GST Act in the state of Odisha as they have not started any business in the state and they have no liabilities under the Act. But, the successful bidder has to produce GST Clearance Certificate in the form GST before signing of agreement.

TERMS & CONDITION

1. Bid document consisting of plans, specification and schedule of quantities along with rates of the works and the set of terms and conditions of contract and other necessary documents are available in web-site www.tendersodisha.gov.in till last date of availability of tender online for bidding.
2. The bids for the works shall remain valid for a period of 90 days from the last date of receipt of bids. If any Bidder/Tenderer withdraws his /her bid/tender before the said period or makes any modification in the terms and conditions of the bid, the said earnest money shall stand forfeited. Conditional Bid is subjected to forfeiture of E.M.D.
3. **Exemption of E.M.D.** To avail the exemption of E.M.D the intending Engineering contractor should have to furnish the affidavit to the effect that he has not been awarded works maximum up to 3 nos. during the current financial year along with the tender paper failing which their case will not be considered for exemption of E.M.D. The successful Engineering Contractor shall have to submit the original registration license before drawl of agreement for making necessary entry in it towards EMD exemption failing which tender will be cancelled and the registration authority will be moved for taking penal action against him.
4. If the rate quoted by the bidder is less than 15% of the tendered amount, then such a bid shall be rejected (The bid quoted up to 14.99% less than the amount put to tender only shall be considered for acceptance) and the tender shall be finalized basing on merits of rest bids through a transparent lottery system.
5. As per the Works Department office memorandam no. 1499 dt 01.02.2023 the bidders are requested to submit Bid Security may be taken in shape of NSC/Post office savings bank account /Post office time deposit account/Kisan Vikas Patra/ Bank Guarntee in favour of the Divisional Officer from any Nationalised Scheduled Bank in India counter guarnted by it s local Branch at Bhubaneswar/e-Bank Guarntee executed on the National e-Governance Servises Ltd. (NeSL) Digital document Execution Portal towards EMD/Initial Security Deposit any other Security Deposit from the contractor of supplier otherwise the bid will be liable for rejection.
6. Additional Performance Security (APS) shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimate cost put to tender shall have to furnish the Additional Performance Security as per the guide line issued by works Department **Vide Ltr No. 4559/ Dt. 05.04.2021.** Additional Performance Security(APS) in shape of NSC/Post office savings bank account /Post office time deposit account/Kisan Vikas Patra/ Bank Guarntee in favour of the Divisional Officer from any Nationalised Scheduled Bank in India counter guarnted by its local Branch at Bhubaneswar/e-Bank Guarntee executed on the National e-Governance Servises Ltd. (NeSL) Digital document Execution Portal within Seven Days of issue of letter of acceptance (LoA) by the concerned Superintending Engineer (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be Cancelled. Further proceeding for Blacklisting shall be initiated against the bidder.
7. Bidders registered as SC, ST & PH contractors desiring to avail concession(S)/ price preference as per prevailing rules should clearly mention regarding claim for avail such benefits in writing in shape of an affidavit and enclose necessary documents and affidavit in support of their claim along with their Bid, failing which their case will not considered for availing price preference as per the above roue.no claim in this regards after opening of bid will be entertained.
8. If the rate quoted by the SC and ST category contractors come to 14.99% (decimals up to two numbers will be taken for all practical purpose) less than the estimated cost after availing 10% price preference ass per Para-2 of works department resolution No. 27748 dt 11.10.1977, then the tender

- shall be finalized by the tender accepting authority through transparent lottery system along with other category of the contractors whose rates are 14.99% less than the estimated cost in presence of all bidders/their authorized representative, ACE, the Superintending Engineer & DAO.
9. No Engineer of rank of Junior Engineer and above or other Gazetted officer employed in Engineering of administrative duties in and Engineering Department of state Government is allowed to work as a contractor for a period of two years after retirement from the Government service without Government permission.
 10. The Original documents along with a set of its Xerox Copies against the scanned copy of Affidavit, Registration Certificate, GST, PAN and other requisite documents submitted through web-site should be produced in the O/o Additional Chief Engineer, Northern Minor Irrigation Circle, Sambalpur for verification on demand after opening of the bid.
 11. Other details including details of Portal Registration, Submission of Bid, Resubmission and Withdrawal of Bid can be seen in the bidding document which is available in web-site www.tendersodisha.gov.in.
 12. Any addendum / corrigendum /cancellation of above tender will be published in the web-site www.tendersodisha.gov.in and in the notice board. The system shall generate a mail to those bidders who have already uploaded their tenders and those bidders if they wish, can modify their tenders.
 13. The on-line bidder shall digitally sign on all statements, documents, certificates uploaded by him owning responsibility for their correctness/authenticity as per IT ACT 2000. If any of the information is found to be false/fabricated/bogus, his/her registration in the portal shall be blocked and bidder is liable to be blacklisted. Authority reserves the right to reject any or all the tenders without assigning any reasons thereof. No bidder can demand the cause of rejection of his offer.
 14. The bidders cannot participate in any tender irrespective of tender amount without registering in CDMS portal as per letter No.30613 dt.22.07.2019 of the Engineer-in-Chief (CIVIL) Odisha. The bid without 8-digit unique code coming under CDMS Portal will be treated as invalid.
 15. If L1 bidders do not turn up for agreement after finalization of the tender, then he shall be debarred from participation in bidding for three years and action will be taken to blacklist the contractor. In case a contractor is black listed, it will be widely publicized and intimated to all departments of Government and also Govt. of India agencies working in the state.
 16. Before acceptance of tender, the successful bidder will be required to submit a work programme and milestone basing on the financial achievement so as to complete the work within the stipulated time and in case of failure on the part of agency to achieve the mile stone liquidated damage will be imposed.
 17. The original affidavit regarding correctness of all documents for each work separately should be made and scan copy of such affidavit is to be uploaded online failing which his tender will not be considered and rejected during opening of tender.
 18. Consequent upon implementation GST with effect from 01.07.2017, the rate offered by agency should be excluding all taxes and duties and including labour cess and royalty, GST as applicable shall be paid extra and TDS as applicable shall be deducted from the Bills.
 19. Amendment to Para 3,5 & 18 rule 29 of Appendix-IX of OPWD code Vol-I "The Single tender received in the 1st call shall be cancelled without opening of the bid & fresh tender will be invited" as per office memorandum No.16 dated 01.01.2015 of Work Department Govt. of Odisha.
 20. Agreement will be drawn works will be taken up as per availability of funds.
 21. Authority will not be held responsible for any technical snag or network failure during the online bidding.

- 22 Quality control tests as per specification for all items of the work executed will be taken in nearby Government Quality control laboratories of Minor/Medium/ major irrigation organization. it is binding on successful bidder to extend all necessary support in getting the tests don till complete of the work in all respect at his own cost.
- 23 Successful tenderer will be intimated for executing agreement.
- 24 Tenderer will be processed/considered as per the office memorandum issued by the work department Govt. of Odisha vide no. 12366 dt 08.11.2013.
- 25 Penalty will be imposed as per agreement condition if the work is not completed within the stipulated period or the progress of work is not as per the work programme.
- 26 . All bidders are requested to remit @ 1% of Bid Security of estimated cost through online.
- 27 Digital document Execution Portal towards EMD / Initial Security deposit any other security deposit)
- 28 If the office happens to be closed on the last date of closing or opening of the bids as specified, holiday in Government local authority the tender will be closed or opened on the immediate next working day at same time and venue respectively, as the case may be
- 29 The revised rate of royalty i:e after addition of all additional charges, 10% DMF and 5% EMF charges with the existing royalty of the minor minerals as the case shall be deducted from the work bills.
- 30 Authority reserves the right to reject any or all the tenders without assigning any reason thereof.
