- Engineer contractor desirous to avail the facility of exemption of EMD is required to submit an affidavit (scan copy) to the effect that he has not yet availed the facility for more than 3 works during the recent financial year and the ST/SC contractor also submit an affidavit (scan copy) for claim against 10% price preference and 50% of EMD exemption for authentication of tender documents. the tender is being submitted on-line must be mentioned in the affidavit failing which the tender will be rejected.
