#### Publication of Provisional Screening List (Phase-II) for Document Verification of MPHWF-2023

In continuation to the results published in **Annexure-I** of this Commission's Notice No. 94(C)/OSSSC dt.07.02.2024, the Commission has been pleased to conduct document verification in **Phase-II** for which the following lists are published and arrangements made as described below.

- (1) Roll Numbers of the candidates provisionally screened for document verification after addition of 5% weightage in marks for Short-Term COVID-19 Healthcare Workers is published at **Annexure-I**.
- (2) Roll Numbers of the candidates provisionally screened for document verification after change of Category is published at **Annexure-II**.
- (3) Roll Numbers of the candidates who are to produce original Caste Certificate in support of their claim for change of Category for verification is published at **Annexure-III**. These candidates are already screened and document verification have already been conducted, but they have to produce original Caste Certificate in support of such of their claim.
- (4) The candidates who have produced ONMEB certificates/any other certificates in place of ONMRC registration certificates or have failed to produce any certificate for the purpose are advised to produce ONMRC valid registration certificates on the date mentioned above failing which no further claim shall be entertained any more. The roll numbers of some such candidates are given in **Annexure-IV**. If any other such discrepancy is noticed by CDMOs /Verifying authorities, facilities may be given to such other candidates to submit ONMRC certificates in support of their claims which may be verified and uploaded along with their biodata.
- (5) The candidates who remained absent during document verification in Phase-I and now interested are also allowed to verify their documents in Phase-II, if they so desire.

The allocation of districts will be done as per their merit and the choice to be exercised in order of preference by the candidates at the time of Document Verification.

The verification of original documents and validation of Biodata of the candidates for MPHWF-2023 shall be conducted on **02.04.2024 at 10.00 AM** onward in the office of Chief District Medical & Public Health Officer of each district as per schedule. If required CDMOs may continue the process to next day to complete the same.

As mentioned in para 1 & 2 (**Annexure-I & II**) are mandatorily required to attend the document verification process before the District Level Board as per the schedule & venue given in their Intimation Letters.

The candidates mentioned in Para 3 & 4 (**Annexure-III & IV**) are required to attend document verification to produce caste certificate / ONMRC Certificate / any other documents in support of their claim. They will carry their previous intimation letters for document verification. If any candidate fails to attend document verification process/ produce original certificate as required, her candidature shall be rejected and she shall not be allowed to participate in the recruitment process any further.

It is reiterated here that candidature of the candidates for this recruitment is purely provisional and is liable for rejection in the event of inadequacy/deficiency found at any stage. Mere participation in the document verification process does not confer any right upon the candidate for appointment.

The candidates are advised to download the Intimation Letters by logging in the web portal of the Commission [www.osscc.gov.in](http://www.osscc.gov.in) with their User ID and Password for document verification.

The candidates are advised to visit the website of the Commission at regular intervals for updates.
