Whereas Hon'ble High Court in their Order dated 27.02.2024 in W.P.(C) No. 22970 of 2019 filed by Odisha State Legal Services Authority-Vrs-State of Odisha have directed the Commissioner-cum-Secretary Health & Family Welfare Department to come with a comprehensive plan to introduce a surveillance mechanism to identify fake doctors in the State.

5.	Representative of IMA (Indian Medical Association)	Member


