2. Bids must be accompanied by security of the amount specified for the work in the table above drawn in favour of S.E., Sundargarh Irrigation Division, Sundargarh. Bid Security will have to be in any one of the forms as specified in the bidding document i.e. KVP / Postal Saving Account / Deposit receipt of scheduled Bank (Bank Draft or Banker cheque is not applicable) / Post Office Time deposit Account duly pledged in favour of the Superintending Engineer, Sundargarh Irrigation Division, Sundargarh. Bids must also be accompanied by Xerox copy of GSTIN, PAN cards, contractor license, Labour License. Bidders desirous to hire machineries or equipments from outside the state are required to furnish 2% of the amount put to tender as bid security.
3. Additional Performance security (**As per Works Department OM No.:-075569000520214559/W., BBSR Dtd.05.04.2021**) shall be obtained from the bidder when the Bid document is less than estimated cost put to the tender. In such an event, only the successful bidder who has quoted less bid price /rates than the estimated cost, put to tender shall to furnish the additional Performance Security as per the following rate.

The applicable Additional Performance Security (APS) shall have to be furnished by the successful Bidder in shape of Term Deposit Receipt pledged in favour of **Superintending Engineer, Sundargarh Irrigation Division, Sundargarh** from any Nationalized / Scheduled bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue the Letter of Acceptance (LOA) by the **Superintending Engineer, Sundargarh Irrigation Division, Sundargarh** (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled. Further proceeding for blacklisting shall be initiated against the bidder (vide Office Memorandum No.:-14459/W, Dtd.20.09.2018 of Works Department, Govt. of Odisha)

The sale & receipt of the tender documents shall start from **dt.10.06.2024 at 7.30 A.M.** and close on **dt.26.06.2024 up to 05.30 P.M.** on all working days during office hours in all the offices where the bids have been notified to be sold. The tender will be received from **dt.10.06.2024 at 7.30 A.M. to dt.26.06.2024 up to 05.30 P.M.** The Technical bid will be opened on **dt.27.06.2024 at 11.00 A.M.** and date of opening of financial bid will be intimated to the eligible bidders after evaluation of Technical Bid. The bids will be opened on in the office of the undersigned in the presence of tenderers or their authorized representatives who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified in the tenders, it will be received and opened on the next working day at the same time and venue.
