The Superintending Engineer, Sambalpur Irrigation Division, Sambalpur, Po-Khetrajpur, Dist-Sambalpur, Odisha, on behalf of Governor of Odisha invites **On-line percentage rate bids in single cover system through e-procurement method of bidding** for the works mentioned in the table below. The Bids should be submitted by the eligible class of contractors as mentioned below, registered with the State Governments and contractors of equivalent grade/class registered with Central Government / M.E.S./ Railways, through On-line in the Government web-site www.tendersodisha.gov.in The bidders should have necessary portal enrolment (with own digital signature certificate). The proof of registration from the appropriate authority shall be enclosed along with the bid. The registered bidders outside of Odisha State can also participate in this on-line tender process after necessary portal enrolment but shall have to subsequently undergo registration with the appropriate authority of the Odisha State Government within one month of acceptance of bid.

1. Cost of Tender Paper-The bidder shall transfer online the cost of bid document as mentioned in Column-06 of above table as part of its bid through a process as mentioned in the DTCN.
2. **EMD:-**The bidder shall transfer online the cost of EMD as mentioned in Column-05 of above table as part of its bid through a process as mentioned in the DTCN. Otherwise, tender will be treated as non-responsive & viable of rejection.
3. **Additional Performance Security:-** If the amount quoted by the bidder is more that 15% less than the tendered amount, then such bid shall be rejected and tender shall be finalized basing on merits

of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system in presence of all the bidders/their authorized representatives which will be held in the office of Superintending Engineer, Sambalpur Irrigation Division, Sambalpur in presence of all bidders/their authorized representatives, the Superintending Engineer and DAO. Hence, all the bidders can enquire in the office of the undersigned regarding lottery before scheduled date as no further correspondence to the bidders in this regard will be made. In the event of the specified date for drawl of lottery being declared a holiday for the office inviting Bid, lottery will be drawn at the appointed time on the next working day.

8. Any addendum / Corrigendum / Cancellation of above tender will be published in the web-site. www.tendersodisha.gov.in, and in the notice board. The system shall generate a mail to those bidders who have already uploaded their tenders and those bidders if they wish, can modify their tenders.
9. Bid documents consisting of qualification, information and eligibility criteria of bidders, plans, specification, and schedule of quantities of the work are available in web-site www.tendersodisha.gov.in and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of sale and receipt of tender papers. Interested bidders may obtain further information at the web-site www.tendersodisha.gov.in.
10. The bid validity period of the tender is for a period of 90 days from the last date of receipt of the bids. If any bidder/tenderer withdraws his bid/ tender before the said period or makes any modification in the terms and conditions of the bid, the Earnest Money Deposit (EMD) deposited at the time of submission of tender shall stand forfeited.
11. No Engineer of Gazetted rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor till a period of two years after his/her retirement from Government Service without Government permission.
12. Other details including details of Portal Registration, Submission of Bid, Resubmission, and withdrawal of bid can be seen in the bidding document which is available in web-site www.tendersodisha.gov.in.
13. The bidders are indispensably required to **submit the Original Copies of Valid License/ PAN CARD/ GSTIN Registration Certificate/ Original Affidavit and authentic proof documents towards purchase of bid documents/ tender papers within 07 (Seven) days from the date of opening of the Bid** otherwise the bid shall be considered as non-responsive, hence liable for rejection. Engineering contractors who are desirous availing the facility of exemption of EMD is required to submit the affidavit in original to the effect that he has not yet availed the facility for 03 (Three) works during the current financial year. Name of the works and authority to whom the tenders have been submitted must be mentioned in affidavit, failing which, the tender will be liable for rejection. However, the original registration license of the Engineering contractor should be produced at the time of opening of tender.
14. If the 1st lowest bidder does not turn up for agreement after finalization of tender, then he shall be debarred from participation in bidding for three years and action will be taken to blacklist the contractor.
15. The bidders shall furnish an affidavit at the time of submission of the bid, about the authentication of the tender documents including Registration Certificate, PAN Card, Valid GST clearance certificate and security etc. failing which the bid shall be considered as non-responsive and thus liable for rejection. No adjustment of EMD will be entertained at all under any circumstance. Labour license is to be produced by the successful bidder at the time of agreement.
16. Amendment to Para 3.5.18. of OPWD code Vol-I & rule-29 of Appendix-IX of OPWD code Vol-II “The single tender received in 1st call shall be cancelled without opening of the bid & fresh tender will be invited” as per Office Memorandum No. 16 dated. 01.01.2015 of Works Department Govt. of Odisha and as per “Works Department O.M. No. 16, dated. 01.01.2015 implies that single tender received in the first call shall be cancelled without opening of bid and in case when more than one

- tenderer have been received in the first call and only a single tender is found to be responsive, the same is also liable to be cancelled due to lack of competitive price bidding. (Vide Letter No. 4410 dt. 19.02.2018 of DoWR& Memo No. 4714 dt. 13.02.2018 of the E.I.C., W.R., Bhubaneswar.
17. The bidder should mention his/her **valid E-Mail Address / Phone No.** in the separate sheet for communication regarding the tender. The date of time of the lottery if required will be intimated to the qualified bidders through their **valid E-Mail Id / Contact Number** provided in the tender website.
 18. All the existing provision of OPWD Code with amendment from time to time will be applicable in deciding the tender. All correspondence regarding the tender process will be communicated by **valid E-mail address** provided in the tender website. All bidders are requested to check their E-mail from time to time regarding the tender. **No claim whatsoever will be entertained for non-receipt of communication in hard copy.**
 19. Agreement shall be drawn only after due verification of ISD & APS of the successful bidder. If any fake documents are detected, criminal proceedings will be initiated against the defaulting bidder and action will be initiated for black listing through the license issuing authority.
 20. As Goods and Service Tax has come into force with effect from **01.07.2017**, **GST** as applicable will be paid extra after gross bill amount prepared vide Section-15 and Section-142 (11-C) of Odisha Goods and Service Tax Act-2017.

If any of the information is found to be false/fabricated/bogus, his/her EMD/BID security shall stand forfeited and his/her registration in the portal shall be blocked and bidder is liable to be blacklisted.
