The highest bid will be accepted by the Department and the highest bidder shall make the full payment of the bid amount to the undersigned and take delivery of the unused articles.

2. Each bidder is required to deposit an amount of Rs.1000/- (Rupees One Thousand) only as earnest money in cash before taking part in the bid. The earnest money will be refunded to the un-successful bidder after the bid is over. In case of successful bidder, the earnest money so deposited will be adjusted against their bid amount. But the earnest money will be forfeited, if the successful bidder refuses to take delivery of the unused articles after the bid is confirmed.




