### Publication of Provisional Results of the Main Examination and Provisional Screening List for Document Verification for the post of Physical Education Teacher (PET)

In pursuance of this Commission's Advertisement No. 2263/OSSCC dt. 27.12.2024, Notice No. 2060/OSSCC, dt. 25.08.2025, Notice No.2556/OSSCC, dt. 10.10.2025 & Notice No.2867/OSSCC, dt. 12.11.2025 the Provisional Results of the Main Examination held on 24.09.2025 in CBRT mode for the post of Physical Education Teacher (PET) is hereby published in the Commission's web portal. Candidates have been provisionally screened for document verification as per merit on the basis of the performance in the Main Examination.

The following lists are published for information of candidates.

- (1) Roll Numbers of the candidates who are provisionally screened and allowed to participate in the Document Verification is at Annexure-I.
- (2) Provisional Minimum Screening Cut-off marks for Document Verification is at Annexure-II.

The verification of original documents and validation of Biodata of the Candidates for the post of Physical Education Teacher (PET) shall be conducted on **5<sup>th</sup> December, 2025** in the office of the Collector of each district as per schedule. For document verification the candidates have been provisionally screened as per their merit, eligibility and availability in each category/ special category.

The candidates provisionally screened for document verification are advised to download the Intimation Letter from **1<sup>st</sup> December, 2025** by logging in the web portal of the Commission [www.osscc.gov.in](http://www.osscc.gov.in) with their registered User ID and Password.

All the provisionally screened candidates are mandatorily required to attend the document verification process before the District Level Board as per the schedule & venue given in their Intimation Letters. If any candidate fails to attend document verification process, his/her candidature shall be rejected and he/she shall not be allowed to participate in the recruitment process any further.

The candidates who have already been employed anywhere else and hence not willing to join in the post of Physical Education Teacher (PET) are allowed to record "**NOT INTERESTED**" by logging into the Commission's website [www.osscc.gov.in](http://www.osscc.gov.in) using their User ID and Password.

Candidates after logging into their respective Accounts have to Click on "**NOT INTERESTED**" option appearing under Online Application Management System in 'Applicant Menu'. This must be done latest by **5<sup>th</sup> December, 2025**.

It is also made clear that candidature of the candidates for this recruitment is purely provisional and is liable for rejection in the event of inadequacy/deficiency found at any stage. It is further clarified here that, after all the processes of verification, candidates will be selected maximum upto 100% as per the advertised vacancies category/ special category wise and/ or availability of eligible candidates. Those who do not come within 100% vacancies shall not be considered for appointment even if participated in the document verification process and found eligible. **Mere participation in the document verification process does not confer any right upon the candidate for appointment.**

Candidates may see the details of their results by logging into the Commission's web portal [www.osscc.gov.in](http://www.osscc.gov.in) with their registered User ID and Password. In the candidate's home page, click the menu "**Result/ Marks**" to visit the link for viewing their results.

The aforesaid information is hereby made available as PROACTIVE DISCLOSURE under the provisions of Right To Information Act, 2005. This will remain available for a period of 60 days for the candidates in the portal. Candidates are advised not to seek these information in any other mode like e-mail, grievance, Janasunani & RTI.
