Publication of Provisional Results of the Main Examination and Provisional Screening List for Document Verification for the post of Trained Graduate Teachers(TGT) - Science (PCM)

In pursuance of this Commission's Advertisement No. 2264/OSSCC dt. 27.12.2024, Corrigendum No. 136/OSSCC dt. 22.01.2025, Notice No.2614/OSSCC, dt. 15.10.2025, Notice No. 2921/OSSCC dt. 20.11.2025 & Notice No. 01/OSSCC dt. 01.01.2026 the Provisional Results of the Main Examination held on 15.11.2025 in CBRT mode for the post of Trained Graduate Teachers(TGT) - Science (PCM) is hereby published in the Commission's web portal. Candidates have been provisionally screened for document verification as per merit on the basis of the performance in the Main Examination.

Roll Numbers of the candidates who are provisionally screened and allowed to participate in the Document Verification is at Annexure-I.

The verification of original documents and validation of Biodata of the Provisionally Screened candidates will be conducted on **5th February, 2026** in the office of the Collector of each district as per schedule. For document verification the candidates have been provisionally screened as per their merit, eligibility and availability in each category.

Date, Venue for Document Verification & Timing details will be available in the Admission Letter to be uploaded online in due course. The provisionally screened candidates for Document Verification are advised to download the Admission Letter by logging in the web portal: www.osscc.gov.in with their User ID and Password

All the provisionally screened candidates are mandatorily required to attend the document verification process before the District Level Board as per the schedule & venue given in their Intimation Letters. **If any candidate fails to attend document verification process, his/her candidature shall be rejected and he/she shall not be allowed to participate in the recruitment process any further.**

It is also made clear that candidature of the candidates for this recruitment is purely provisional and is liable for rejection in the event of inadequacy/deficiency found at any stage. It is further clarified here that, after all the processes of verification, candidates will be selected maximum upto 100% as per the advertised vacancies category wise and/ or availability of eligible candidates. Those who do not come within 100% vacancies shall not be considered for selection even if participated in the document verification process and found eligible. **Mere participation in the document verification process does not confer any right upon the candidate for selection.**

Candidates may see the details of their results by logging into the Commission's web portal www.osscc.gov.in with their registered User ID and Password. In the candidate's home page, click the menu "**Result/ Marks**" to visit the link for viewing their results.

The aforesaid information is hereby made available as PROACTIVE DISCLOSURE under the provisions of Right To Information Act, 2005. This will remain available for a period of 60 days for the candidates in the portal. Candidates are advised not to seek these information in any other mode like e-mail, grievance, Janasunani & RTI.

No hardcopy of Intimation Letter will be sent to any candidate by post or any other means.
