On the recommendation of the Odisha Public Service Commission pursuant to the advertisement No. 15 of 2022-23, the following candidate is hereby appointed temporarily as Assistant Professor in the discipline of Nephrology under OMES Cadre of Health and Family Welfare Department in the Academic Level 12 of First Schedule of this Department Notification No.33012 dated 16.12.2019 with other allowances as admissible from time to time from the date of his actual joining in the post until further orders.

1. The appointment is purely temporary and terminable at any time without prior notice and without assigning any reason thereof. His service is transferable and comes under the purview of the transfer policy for their posting in any Government Medical Colleges, as and when required.
2. The appointee shall be on probation for a period of one year.
3. The place of posting has been decided upon counselling, conducted by the Director, Medical Education and Training, Odisha, Bhubaneswar as per the guidelines issued by General Administration and Public Grievance Department vide Resolution No-14327/Gen, dated 04.07.2017.


