Publication of Provisional Screening List (additional) for Document Verification for the post of Sanskrit Teacher

In continuation to the results published vide this Commission's Notice No. 3020/OSSSC dt. 29.11.2025, the Roll Numbers of the candidates who are provisionally screened (additionally) and allowed to participate in the document verification for the post of Sanskrit Teacher is published at Annexure-I.

The verification of original documents and validation of Biodata of the Candidates for the post of Sanskrit Teacher shall be conducted on **5th February, 2026** onwards in the office of the Collector of each district as per schedule.

The candidates provisionally screened (additionally) for document verification are advised to download the Intimation Letter to be uploaded online in due course from the web portal of the Commission www.osscc.gov.in with their registered User ID and Password.

All the provisionally screened candidates are mandatorily required to attend the document verification process before the District Level Board as per the schedule & venue given in their Intimation Letters. If any candidate fails to attend document verification process, his/her candidature shall be rejected and he/she shall not be allowed to participate in the recruitment process any further.

It is also made clear that candidature of the candidates for this recruitment is purely provisional and is liable for rejection in the event of inadequacy/deficiency found at any stage. It is further clarified here that, after all the processes of verification, candidates will be selected maximum upto 100% as per the advertised vacancies category/ special category wise and/ or availability of eligible candidates. Those who do not come within 100% vacancies shall not be considered for appointment even if they participated in the document verification process and found eligible. **Mere participation in the document verification process does not confer any right upon the candidate for appointment.**

The aforesaid information is hereby made available as PROACTIVE DISCLOSURE under the provisions of Right To Information Act, 2005. This will remain available for a period of 60 days for the candidates in the portal. Candidates are advised not to seek these information in any other mode like e-mail, grievance, Janasunani & RTI.

No hardcopy of Intimation Letter will be sent to any candidate by post or any other means.

Candidates are advised to visit the website of the Commission at regular intervals for updates.
