Counselling for choice of District for the posts of Trained Graduate Teachers (TGT) – Science (PCM), Trained Graduate Teachers (TGT) –Science (CBZ) & Physical Education Teacher (PET)

In pursuance of Advertisement No. 2264/OSSSC, dt.27.12.2024, No.2265/OSSSC, dt.27.12.2024, No.2263/OSSSC, dt.27.12.2024, Corrigendum No. 136/OSSSC dt. 22.01.2025, Corrigendum No. 120/OSSSC, dt.22.01.2025, Notice No.235/OSSSC, dt.20.01.2026, Notice No. 226/OSSSC, dt.20.01.2026, Notice No. 3029/OSSSC, dt.29.11.2025 & Notice No. 361/OSSSC, dt.31.01.2026, the Commission have been pleased to decide that counselling for choice of District for the post of Trained Graduate Teachers (TGT)-Science (PCM), Trained Graduate Teachers (TGT)-Science (CBZ) & Physical Education Teacher (PET) will be held on 30th March and 31st March 2026 in the office of Odisha Sub-ordinate Staff Selection Commission, Bhubaneswar. The candidates are called for counselling in order of merit to choose their Districts. The Roll Nos. of candidates provisionally allowed to participate in the counselling is published at **Annexure-I, II and III**.

N.B.- Some candidates more than the number of category wise vacancies advertised have been called for counselling. They will get chance to participate in the counselling process if some of the selected candidates higher in the Merit List fail to attend the counselling process or found ineligible for these posts.

The candidates are required to follow the instructions of counselling as given below.

1. The candidates must attend the counselling on the date and time fixed and wait till their turn comes. **They must come with the Admission Letter along with original and photocopy of Adhaar card/Voter ID card/any other Government Identity Proof, Educational Certificates and Marksheets.**
2. Those who are unable to come for the counselling on the date and time fixed may send their authorized representative with authorization letter. The representative shall come with his/her Adhaar card/Voter ID card/any other Government Identity Proof along with the candidate's Admission Letter along with his/ her original and photocopy of Adhaar card/Voter ID card/any other Government Identity Proof, Educational Certificates and Marksheets to attend the counselling. **(Sample authorization letter is given at Annexure-IV).**
3. Latecomers shall lose the opportunity of exercising his/her choices for the districts. He / she may be allowed to exercise his/ her choice for the district available at that point of

time. Since counselling will start at the scheduled time, latecomers will be deprived from exercising their right of choice to that extent.

4. Candidates or his/her authorized representative, as the case may be, if remained absent shall not be allowed any further opportunity to participate in the next stage of recruitment process any further.
5. No request for extension of time for counselling shall be allowed under any circumstances.
6. The candidates/their representatives are required to exercise their choice for the district on the spot considering the vacancy position as available at that point of time with respect to the Annexure- I of the respective Advertisements. No further request for change of choice for districts shall be allowed, thereafter.
7. The decision of the Commission regarding allocation of District shall be final.
