In pursuance of the Advertisement No. 938(C)/OSSSC dt.29.12.2023, Notice No. 2085/OSSSC dt.01.09.2025, No. 519/OSSSC dt.16.02.2026 & No. 963/OSSSC dt.17.03.2026 for conduct of Main Examination for the posts of RI, ICDS Supervisor, ARI, Amin & SFS under CRE-2023(IV) on **26<sup>th</sup> April, 2026** in **CBRE** mode in a single shift (**Time – 9:00 A.M. to 12:00 P.M.**), the Commission has been pleased to notify the following terms and conditions.

1. Candidates are advised to download the Admission Letter by logging into the web portal of the Commission [www.osscc.gov.in](http://www.osscc.gov.in) with their User ID and Password and clicking on the link "**Download Admission Letter for the Main Examination of CRE-2023(IV)**". They may take the Mock test while downloading Admission Letter by clicking the link "**Mock Test for Main Examination of CRE-2023(IV)**".
2. Venue and center details of the examination are available in the Admission Letter. No hard copy of Admission Letter will be sent to any candidate.
3. In case of Tie among candidates with the same score in the Main Examination the candidate having lesser negative mark shall be placed above in rank vis-à-vis others. If there is again a Tie among some candidates having equal negative marks then the candidate elder in age will be placed above others on the basis of their date of birth.
4. Examination Centers have been identified in all districts. But due to inadequate infrastructure/capacity at Examination Centers in some districts, some candidates are allocated Examination Centers other than in their preferred district given at the time of submission of online application.
5. PwD candidates having benchmark disability shall be allowed compensatory time of 60 minutes (@20 minutes per hour) as per rules.
6. The marks obtained by the candidates in the Main Examination shall be taken into consideration for determining their final order of merit.
7. The Commission reserves the right to change the date/time/venue of examination in case of any exigency.

All other terms and conditions of the Advertisement published shall remain unaltered.

Candidates are advised to visit the website of the Commission at regular intervals for updates.
