Verification of genuineness of claims of PwD candidates for the posts of Sevak/Sevika & Tribal Language Teacher (TLT)

In pursuant to Notice No. 53/OSSCC dt.12.01.2026 the verification of genuineness of Disability Certificates/UDID cards of PwD candidates as at **Annexure-1** shall be conducted on **20th and 21st April, 2026 at 10:00 AM** by the Medical Assessment Board in the office of the Superintendents of the Medical College & Hospitals concerned.

All the aforesaid candidates are mandatorily required to attend the verification process before the Medical Assessment Board as per the schedule & venue given in their Intimation Letters. If any candidate fails to attend verification process, his/her PwD claim shall be disallowed.

It is also made clear that candidature of the candidates is purely provisional and is liable for rejection in the event of inadequacy/deficiency found at any stage. Mere participation in the verification process does not confer any right upon the candidate for appointment.

The candidates are advised to download the Intimation Letters by logging in the web portal of the Commission www.osscc.gov.in with their user ID & Password.

The candidates are advised to visit the website of the Commission at regular intervals for updates.
