1. The Superintending Engineer, Bargarh Irrigation Division, Bargarh on behalf of Hon'ble Governor of Odisha invites **on-line** Percentage Rate Tenders through e-procurement for execution of following works. The bid should be submitted by eligible **class of Contractors** through on-line in the Government website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in). The bidders should have necessary portal enrolment (with own digital signature certificate). The registered bidders outside of **ODISHA** can also participate in this on-line Tender process after necessary portal enrolment but shall have to subsequently undergo registration with appropriate authority of the State Govt. within a month from acceptance of bid.

3. Bid document consisting of qualification, information and eligibility criteria of bidders and tender schedule of the works are available in web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of sale and receipt of tender papers. Interested tenderers may obtain further information at the web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in).
4. **Cost of Tender Paper** - The bidder shall transfer online the cost of bid document in the table **Column-6** above as part of its bid through a process as mention under DTCN
5. **E.M.D. required** - The bidder shall transfer online the Earnest money deposit/ Bid Security of the amount specified for the work in the table **Column-5** above as part of its bid through a process as mentioned under DTCN. Bidders desirous to hire machineries or equipment's from outside the State or owned but deployed outside the State are required to transfer online 2% of the amount put to tender as bid security.

6. As goods and service tax (**GST**) shall be applied as per prevailing rules
7. The bids for the works shall remain open for acceptance for a period of 90 days from the last date of receipt of bids. If any bidder/ tenderers withdraws his bid/tender before the said period or makes any modification in the terms and condition of the bid, the EMD deposited at the time of submission of tender shall stand forfeited.
8. No Engineer of Gazetted rank or other Gazetted Officer employed in Engineering of Administrative duties in an Engineering department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service without Government permission.
9. Other details can be seen in the bidding documents, which is available in web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in)
10. Authority reserves the right to reject any or all of the tenders without assigning any reasons thereof.
11. The contractor has to mention percentage excess or less over the estimated cost (in figure and words).
12. In percentage rate of tender only percentage quoted shall be considered. Percentage quoted by the contractor shall be accurately filled in figure & words, so that there is no discrepancy. If any discrepancy is found in the percentage quoted in words and figures then percentage quoted by the contractor in words shall be taken as correct. If excess/less is not mentioned, then the rate will be treated as percentage excess.
13. The contractor will write percentage Excess or Less up to two decimal points only if he writes the percentage excess or less up to more than two decimal points, the two decimal points shall only be considered without rounding up.
14. Engineer contractor desirous to avail the exemption of EMD is required to submit an affidavit to the effect that he/she has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to whom the tenders have been submitted must be mentioned in the affidavit and he/she should produce his/her original registration certificate at the time of finalisation of the tender for verification of the license, failing which the tender will be rejected.
15. A bidder can submit only one tender paper for a particular work, submission of more than one tender paper by a bidder for a particular tender will be liable for rejection of all such tender papers as per Works Department letter No.4985/WE dated.28.03.2007.
16. The tender accepting authority will verify the originals of all the scanned documents of the lowest successful bidder only within 07 days of opening//lottery of the tender. In the eventuality of failure on the part of the lowest bidder to produce the original documents, he will be debarred in future from participating in tender for 3 years and will be black listed by the competent authority. In such a situation, successful L-2 bidder will be required to produce his original documents for consideration of his tender at the negotiated rate equal to L1 bidder.
17. The scheduled Caste / Scheduled Tribe / Contractors desirous to avail the facility of preference as per Govt. rule should enclose the copy of their registration certificate stating the fact of caste by their registration authority with the bid, failing which they will not get price preference as per above rule.
18. The bid will be opened online on **Dt.01.06.2026 at 10.00 A.M.** in the office of the undersigned in the presence of the bidder or their authorized agents who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the corresponding next working day at the same time and venue.
19. The bidders shall have to produce an affidavit in support of authenticity of documents like credential, **GSTIN** certificate, contract license, PAN Card including the E.M.D accompanying the bid. The authority reserves the right to verify the authenticity of document in case any doubt or complain arises. GST on works contract as applicable at the time of payments shall be paid extra over the gross amount.


20. **Additional Performance Security** shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish additional performance security as per the **Office Memorandum No.173/W dt.03.01.2026 & no 632/W, Bhubaneswar dated. 09.01.2026 of Government of Odisha, Works Department** mentioned in the bid documents in shape Term Deposit Receipt pledged in favour of Divisional Officer/ Bank Guarantee in favour of the Divisional Officer from any Nationalized / Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of letter of acceptance (LoA) by the Divisional Officer (by email) to the successful bidder otherwise the bid of the successful bidder shall be canceled and the earnest money deposit/ bid security shall be forfeited. Further proceeding of blacklisting shall be initiated against the bidder as per Works Department Memorandum No.14299 dt.03.10.2017 and Amendment made vide Office Memorandum No.14459 dt.20.09.2018. The time period of such APS deposit must be more than the duration of the work.

Additional Performance Security should be furnished by the successful bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the Additional Performance Security (APS) as per

(Office Memorandum No. 173/W dt.03.01.2026 & no 632/W, Bhubaneswar dated. 09.01.2026 of Government of Odisha, Works Department)

Additional Performance Security (APS) in shape of TDR/ STDR issued by Nationalised Bank/ NSC/KVP/ Post Office Time Deposit/ Post Office Saving Bank account pledged in favour of **Superintending Engineer, Bargarh Irrigation Division, Bargarh** with seven days i.e. from the date of issue of intimation to the bidder, if the bidder fails to deposit the required APS by the schedule date and time, the bid stands automatically cancelled along with forfeiture of Earnest Money Deposit no complaint what so ever will be entertained hereafter. Further proceeding for black listing shall be initiated against the defaulting bidder/ contractor.






